# **Explanatory Notes**

# **Version 2 of the 2015 Canadian Anti-Doping Program (CADP)**

## PART A - STRUCTURE AND SCOPE

### **Section 1.0 Introduction**

• The term *International Federation* has replaced all references to international sport federation to ensure consistency with the World Anti-Doping Code (Code).

### **Section 4.0 Jurisdiction**

- 4.1 Athlete Support Personnel has been more clearly identified as Persons bound by the rules of the CADP. For consistency, references to Athlete Support Personnel have been added to all applicable sections of the CADP.
- 4.3 Registrant has been added as an example of those individuals to which the CADP applies.
  This change is based on CCES' and Sport Organizations' adoption of the new Canada Not-for-profit Corporations Act. For consistency, references to Registrants have been added to all applicable sections of the CADP.
- 4.3 a) Participants have been added alongside members and registrants as an example of those
  individuals bound by the rules of the CADP. For consistency, references to Participants have
  been added to all applicable sections of the CADP.
- 4.3 b) Member organization replaces references to member where applicable to distinguish between members referring to individuals and members referring to organizations. For consistency, references to member organizations have been added to all applicable sections of the CADP.
- 4.3 e) This section has been added to clarify that Athletes, Athlete Support Personnel and other Persons serving a period of Ineligibility remain under the jurisdiction of the CADP until the end of their period of Ineligibility regardless of their participation status within their Sport Organization.

### PART B - IMPLEMENTATION

### **Section 5.0 Adoption**

 5.1 A section of the text regarding the fundamental commitment to anti-doping efforts has been removed to avoid duplication in the CADP as the essence of this content is captured in Section 1.0 Introduction and Section 2.0 General Principles.





• 5.3. g) This section has been removed from the CADP. The requirement that *Sport Organizations* pay to the CCES an annual CADP adoption contribution has been removed from the CADP.

#### Section 6.0 Financial Contributions

• This section has been removed from the CADP as the requirement that *Sport Organizations* pay to the CCES an annual CADP adoption contribution has been removed.

## **Section 7.0 General Responsibilities**

- Section 7.0 General Responsibilities has been renumbered based on the removal of the abovementioned Section 6.0 Financial Contributions, and is now referred to as Section 6.0 General Responsibilities. All subsequent sections have also been renumbered accordingly. Any references to Section 7.0 found below refer to the previous version of the CADP.
- 7.0 The references to an Adoption Contract and an *Athlete* Contract have been removed in keeping with the removal of Section 6.0 Financial Contributions.
- 7.1.2 Other *Persons* has been added alongside *Athletes* and *Athlete Support Personnel* as an example of those individuals bound to this section of the CADP. For consistency, references to other *Persons* have been added to all applicable sections of the CADP.
- 7.1.10 7.1.13 These sections have been removed and replaced with Rule 6.3 applicable to
   Athlete Support Personnel. This new rule clarifies the responsibilities of Athlete Support
   Personnel pursuant to the CADP and includes:
  - 1) Having knowledge of and complying with all applicable anti-doping policies and rules adopted pursuant to the CADP;
  - 2) Directing *Athletes* to obtain expert advice and accurate information on anti-doping related matters and the CADP;
  - 3) Cooperating with the *Athlete Testing* program;
  - 4) Using his or her influence on *Athlete* values and behavior to foster anti-doping attitudes; and
  - 5) Not *Using* or *Possessing* any *Prohibited Substance* or *Prohibited Method* without acceptable justification.
- 7.1.4 To avoid duplication, this section has been removed as this is captured under 6.1.1.
- 7.5 This section has been reworded to remove redundancies.

## **Annex 1: Adoption Contribution for 2015**

• In keeping with the removal of Section 6.0 Financial Contributions, Annex 1: Adoption Contribution for 2015 has also been removed.

### PART C – CANADIAN ANTI-DOPING PROGRAM RULES

### **Preface**

Sport Organizations has been added to clarify the body adopting the CADP.

- World Anti-Doping Code (Code) has replaced World Anti-Doping Agency (WADA) Code as the correct name for the Code.
- International Standards has been removed and only those terms defined under the Code will be italicized throughout the document.

## **Rule 1: Application of the Rules**

• 1.3.1.4 This section has been added in keeping with the addition of Section 4.3 e) referring to those individuals serving a period of *Ineligibility* being bound by the rules of the CADP regardless of their participation status within their *Sport Organization*.

### **Rule 4: The Prohibited List**

• For the purposes of ensuring the link to the current version of the WADA Prohibited List is available, the link has been removed from this section and has been included in Appendix 3: Documents Index. All other links to the WADA website and other external organizations integrated in the remainder of the CADP have been centralized in Appendix 3: Documents Index.

### **Rule 7: Results Management**

• 4.2.1 – The term "encrypted" has been replaced with "encoded" to more accurately reflect the World Anti-Doping Agency Model Rules and current practices.

#### **Rule 19 Education**

 19.2 This section has been renamed and reworded in keeping with the values-based and principle-driven approach to preventing and deterring doping set out in Section 1.0 Introduction and Section 2.0 General Principles.

# **Appendix 1: Definitions**

• The definition of *Student-Athlete* has been revised to reflect the renaming of Canadian Interuniversity Sport (CIS) to U Sports.
